**TOURNAMENT FEES** - Tournament Fees Include Green Fee, Golf Cart, Range Balls, Prize Fund, Scoring, and Meal Package (See tournament meal packages for selections). The minimum number of paid players necessary to host an event is 88. You will be billed for 88 players even if final participation falls below that number. **If by 7 days prior to the event it is projected that the event's participation will not exceed a minimum of at least 72 players Oakdale Golf & Country Club reserves the right to cancel the event.** The maximum number of players that can be accommodated in a tournament is 156.

**2019 Returning Event Rates\* \$108.00 per player**

**2019 New Event Rates \$110.00 per player**

\*Returning Event Rates apply only to those events that hosted an event in 2017 and have returned their signed contract and deposit by January 31<sup>st</sup>, 2019. All new events booked for 2019 will be subject to the 2019 New Event Rates as long as they return their signed contract and deposit by January 31<sup>st</sup>, 2019. 2019 New Events that fail to contract by that date will be subject to an additional \$3 per player. Exceptions to this policy will not be made without a written extension from OGCC Management.

**RESERVATION DEPOSIT** - A \$500.00 deposit and signed contract is required by January 31<sup>st</sup>, 2019 to reserve a date for 2019. The deposit is refundable if the tournament is cancelled more than 6 months in advance. The deposit may be rolled over *one time* to an event for 2020 if you cancel at least 1 month prior to the event date. **Returning Events have the first right of refusal for their same date as long as they return a signed contract and deposit by January 31<sup>st</sup>, 2019. After that Oakdale Golf & Country Club reserves the right to release that date to another event requesting it unless other arrangements have been made with the Head PGA Professional.**

**FACILITY FEE** – All events that are not guaranteed by an OGCC Member will be subject to a \$250 Facility Fee.

**OGCC MEMBER GUARANTEE** – Events that are guaranteed by an OGCC Member may have the \$500 Reservation Deposit and the \$250 Facility Fee waived as long as they return their signed contract by the January 31<sup>st</sup>, 2019 Deadline and the event takes place as scheduled. The guaranteeing member will be responsible for any costs incurred by the event that are outstanding more than 90 days following the event, or the \$250 Facility Fee if the event is cancelled less than 90 days from its scheduled date.

**COURSE MARSHALLS/STAFF** - Two Course Marshalls/Assistants will be provided for each event, for which a mandatory fee of \$175.00 will be charged. Additional course staff (i.e. beverage cart attendants, club professionals for contests, etc.) are available for \$85.00 each, but must be arranged in advance.

**GOLF SHOP CREDIT** – Every event will receive \$10 per player credit in the golf shop that may be used in the form of gift certificates, for tee prizes, or to purchase merchandise in the golf shop. **In addition, if events chose to purchase their tee gifts through OGCC they may earn an additional credit of \$2.50 per player in the golf shop towards these purchases if the purchase is valued at a minimum of \$25 per player at the tournament minimum amount of 88 players.**

**CART POLICY** – OGCC provides one cart for every 2 paid players playing under the terms of this contract and The Event will be responsible for any and all damages that may occur to the provided carts on the day of the event. The Player Assistants will be required to warn any players that are found to be driving said carts in a reckless fashion of any sort that they may lose cart privileges if the behavior in question fails to cease and that their names will be recorded and delivered to the Tournament Chairperson and the Head Golf Professional. Included with the Tournament Package Price each event is entitled to the use of 2 extra carts for volunteers. Additional carts as needed will be billed at \$25 each.

**DRESS CODE** - Oakdale Golf and Country Club has a Dress Code Policy that will be provided. In signing this contract you are stating that you will read and understand that everyone associated with your event will be subject to compliance. **It is your responsibility to inform all players, volunteers, and guests of the OGCC Dress Code.**

**PAYMENT POLICY** - You will be billed your event's cost, less the deposit, no more than 4 days after its completion with final payment expected **no more than 30 days** after receipt of invoice. Returning events may have the next year's deposit included in their statement if so desired.

**FOOD POLICY** – Tournament participants' meal charges are included in the tournament package price. **Total event meals will be billed on a per box lunch and per plate taken basis.** You will need to provide the club with a count for participant, non-participant guests, and volunteer meals that will be needed at least 7 days prior to your function. This will be the minimum number of meals billed to your event. Additions may be made to this figure up to 3 days prior to the day of the event. **Bringing in outside food for an event is not permitted under any circumstances unless prior approval has been given by the Food & Beverage Manager, however, pre-packaged goods (i.e. candy, energy bars, etc.) included as part of a tee-package are acceptable.** \_\_\_\_\_ *Please initial*

**BEVERAGE POLICY** - Oakdale Golf and Country Club supports responsible drinking habits. Guests who appear to have consumed more alcohol than appropriate will not be served. **Alcohol served on OGCC premises must be done by a member of the OGCC Staff. In accordance with California State Law, no minors (persons under age 21) will be served alcoholic beverages. OGCC staff reserves the right to ask any guest to provide identification.** All tournaments are required to purchase a one-day ABC Permit for \$25.00. All beverages must be purchased from the club with the only exception being made for donated beverages for which appropriate corkage will be billed. If you provide beverages for your event and they run low more than an hour prior to the end of the event OGCC will replenish your supply from our stock and bill you accordingly. Corkage for donated beverages not including alcohol will be \$3.50 per player. Corkage for donated beverages, including alcohol, will be \$5.75 per player. Corkage for wine served with dinner is additional and will be \$10.00 per bottle or \$15.00 per magnum. Beverage carts on the course are a cost of \$75.00 each for the day of the event. Any donated beverages that are not picked up within 72 hours of the conclusion of the event become the property of OGCC. \_\_\_\_\_ *Please initial*

**INSURANCE** - You must obtain a certificate of insurance in the amount of 1 Million Dollars for bodily injury and property damage. \_\_\_\_\_ *Please initial*

**DAMAGES** - You are responsible for any damages to Oakdale Golf & Country Club property or equipment that occurs during the event. \_\_\_\_\_ *Please initial*

As the tournament chairperson, I do hereby agree to and understand the terms and conditions set forth above and will be fully responsible for all damages and any other non-estimated expenses that may occur during the event.
